If the dissertation referred to in the first sentence was defended as part of a doctoral programme of study begun before 29 May 1998 as a postgraduate course (Section 98(1)(c) of the Higher Education Act), it shall be recognised as a rigorous thesis under these Regulations; in this case, reimbursement of costs shall not be required. The second sentence shall also apply to the recognition of the rigorous examination or the state doctoral examination as an oral examination under these Regulations.
